Procedure to convert a foreign driver's license into Japanese one

- Those who meet the following conditions are able to apply for the procedure to convert a foreign driver's license into Japanese.
 - (1) Having a driver's license issued by a foreign government agency.

International driver's licenses are not available for this procedure.

(2) Having stayed in the country where the license was issued for 3 months or more in total after the acquisition.

In case you obtain a foreign driver's license on a sightseeing trip, you cannot convert it unless you stayed in the country for 3 months in total after the acquisition.

(3) The foreign driver's license is in the valid period.

The expiration period varies depending on the countries.

You are required to apply during the period your license is valid.

2 Reception

This service is reservation-only. Please make a reservation by phone or at the Driver's License Center (window No. 7) by the day before.

Reservation by phone is available 9:30 to 12:00 and 14:00 to 17:15 on weekdays (excluding national holidays and new-year holidays: between December 29 to January 3).

Document review is carried at 9:00 am or 2:00 pm on weekdays (excluding national holidays and new-year holidays: between December 29 to January 3).

3 Process of the Procedure

- (1) For those who have driver's licenses issued by exception nations
 - If you have a driver's license issued by one of the following 29 countries or a region, you will be exempted from the knowledge test and the driving skills test.

Document review → Aptitude test → Delivery of License

Iceland, Ireland, The United States of America (State of Ohio, Oregon, Colorado, Virginia, Hawaii, Maryland, Washington only), The United Kingdom, Italy, Australia, Austria, Netherlands, Canada, South Korea, Greece, Switzerland, Sweden, Spain, Slovenia, Czech Republic, Denmark, Germany, New Zealand, Norway, Hungary, Finland, France, Belgium, Poland, Portugal, Monaco, Luxembourg, Taiwan.

- O If you have a driver's license issued by The United States of America (State of Indiana only), you will be exempted from the driving skills test.
 - Document review → Aptitude test → Knowledge test → Delivery of License
- (2) For those who have driver's licenses issued by outside of counties mentioned above Document review → Aptitude test → Knowledge test → Driving skills test → Delivery of License

4 Requirements

- (1) Photograph for application (One photo is required for each vehicle category you apply for.) The size is 3 centimeters length by 2.4 centimeters breadth.
 - The Photos need to be taken within 6 months before the application.

Burmese, Mongolian, Ukrainian, Sinhalese, Urdu, Arabic, and Hindi.

- (2) Certificate of residence (in which your legal domicile, nationality or region is written)

 Japanese driver's license (if you have one already) or Myna driver's license.

 Please prepare a certificate of residence in which your individual number is not recorded.

 If you have both driver's license and Individual Number Card, please bring them.

 If your individual number is in it, you will be required to mask it.
- (3) Resident card (if you are a foreigner)
- (4) Passport (which clarify you stayed the issuing country for 3 months or more after you obtained the license)

You cannot convert your driver's license if the passport has no immigration stamps of the country where your driver's license was issued and your period of stay cannot be confirmed.

Bring anything proves your period of stay, for example, your expired passport, flight tickets etc.

(5) Certificate of embarkation and disembarkation

Please bring a certificate of your embarkation and disembarkation record by government agency of the country where issued your driver's license, if possible.

You can omit it if you are sure to certify your embarkation and disembarkation record by your passport.

- X Some other documents might be required if you can neither obtain a certificate of embarkation and disembarkation record nor prove your date of immigration by your passport. Please contact us.
- (6) Foreign driver's license

- If your driver's license does not have the date of issue or the date of acquisition, please request a document from relevant country so that the date can be confirmed. (e.g. driving record, driving history.)
- If you have a driver's license issued by another country than you apply to convert, please bring it.
- ※ If you have some documents attached to your foreign license or a certificate of driver's license acquisition, please bring it with you (e.g. Official Receipt issued by Republic of Philippine, Certificate issued by LTO (Land Transportation Office))
- (7) International driver's license (if you have)
- (8) Japanese Transition of the foreign driver's license

Translation into Japanese is made at the following organizations: (Fee-charging)

- O Government agency and consular agency of the country that issued your driver's license
- In the case of Taiwan, the Japan-Taiwan Relation Associate (translated text from Taiwanese License offices is also available)

Applicants for the Myna driver's license must bring your Individual Number Card.

You cannot apply for an Myna driver's license in the following cases:

- · Expiration of an Individual Number Card
- · Damage to IC chip in an Individual Number Card

· Insufficient capacity of IC chip in an Individual Number Card

<u>Digital Certificate for signature PIN code</u> (Combination of 6 to 16 characters composed of <u>alphabets and number</u>) is required for your various procedures (Mynaportal Cooperation, One-stop service for change of address), so please check it beforehand.

* Police agencies do not issue an Individual Number Card.
